## Introduction

The inspection was carried out by one Additional Inspector. The inspector evaluated the overall effectiveness of the school and investigated the following issues:

- how effectively the school supports learners to make progress;
- how effectively pupils' involvement in target setting supports learning;
- how well pupils develop the appropriate skills to become responsible members of the community.

Other aspects of the school's work were not investigated in detail, but the inspector found no evidence that the school's own assessments, as given in its self-evaluation, were not justified and these have been included where appropriate in the report.

## Description of the school

This is a larger than average sized school on the outskirts of Bishop's Stortford. The proportion of pupils who are eligible for free school meals is below average. Most pupils are of White British backgrounds. The proportion of pupils with learning difficulties and/or disabilities, including those with a statement of special educational need, is below average. Attainment on entry varies from year to year but is broadly above expectations. The school has achieved a national award for information and communication technology (ICT) and a Healthy School award.

## Overall effectiveness of the school

### Grade: 1

This is an outstanding school. A significant factor in this is the excellent leadership of the headteacher who, together with the very effective support of staff and governors, leads a determined drive to raise standards and improve provision. One parent expressed a typical view in commenting that her child attends 'an excellent school with excellent staff who work hard to get the best out of all the children'.

Achievement for all pupils is excellent and standards are exceptionally high. The excellent start to learning which children receive in the Foundation Stage is consolidated in Key Stage 1. The standards reached at the end of Year 2, in reading, writing and mathematics, have been significantly above average for the last five years. Standards for the current Year 2 remain well above average. At Key Stage 2, based on the very firm foundations of learning in previous years, the excellent rate of progress continues. Results of national tests at the end of Year 6 in 2007 in English, mathematics and science were significantly above average and this has been the case for the previous four years. The current Year 6 pupils are expected to improve further on these high standards, although the proportion of pupils who attain the higher levels in science is not as high as it could be.

A significant factor in the high achievement is the excellent personal development. Pupils love coming to school because relationships are excellent and learning is fun and challenging. This helps them to develop a positive and confident approach to learning. Attendance is above average, although figures are affected by some families taking holidays during term time. Most pupils have an excellent understanding of how to lead a healthy lifestyle and are full of life and eager to learn. Spiritual, moral, social and cultural development is excellent. Pupils have many opportunities to accept responsible roles around the school, for example as playleaders, lunchtime monitors and school councillors. They contribute effectively to the wider community, jointly celebrating local events such as Harvest Festival and pupils regularly organise fundraising events to support local and national charities. Pupils' high levels of basic skills, maturity and confidence prepare them exceptionally well for the next stage in their education.

Teaching is excellent overall. Strong features of teaching include very positive relationships and excellent use of assessment to provide work which is suited to differing abilities. Teaching is regularly inspiring and challenges pupils so that they are eager to learn. Parents frequently refer to the high quality of teaching and the caring nature of the staff. The school makes very good use of support staff to support and extend the learning of pupils who need additional support or those who find learning more difficult. As a result, they make the same very high rate of progress as their peers.

Pupils want to learn because the curriculum is excellent. It is very well adapted to the needs of all abilities and ages and enrichment is especially good. Pupils enjoy the wide provision for extra-curricular activities and the very wide range of visits and visitors are very popular. The school makes very effective use of specialist teachers to provide additional support for a number of subjects. A particular strength of the school is the provision for music. All pupils have the opportunity to learn to play the recorder by the end of Year 3, and many continue to learn a wide range of instruments throughout Key Stage 2. Music is viewed with great importance and pupils enjoy frequent opportunities to perform musically which contributes effectively to their enjoyment. As one pupil said, echoing the views of others, 'you can't have a school without

music!' The very strong focus on literacy, numeracy and information and communication technology (ICT) coupled with very good links with local schools greatly enhance the curriculum.

Care, guidance and support are outstanding. The good links with parents and families create a very strong family atmosphere in school. Pupils know that they are very well cared for and known well to staff. This helps to give pupils a real sense of belonging. They feel secure and valued at school. Child protection and risk assessment procedures are in place and the school has appropriate arrangements for safeguarding children. Very effective assessment and tracking systems enable teachers to plan thoroughly, and pupils have a clear understanding of what they need to do in order to improve.

Leadership and management are outstanding. The headteacher has a clear vision for improvement and strong commitment to raising standards and improving provision. As part of its thorough self-evaluation, all aspects of provision are analysed and developments prioritised. The school improvement plan is clear and comprehensive. Despite the high standards reached, the school is continually and successfully looking to improve further. Governance is excellent. Governors know the school extremely well and are very supportive. Their work is enhanced by the close links each governor has with a group of pupils as they progress through the school. Because of this, governors are very well placed to hold the school to account for its performance. There has been excellent progress since the previous inspection. Exemplary leadership, a shared and cohesive drive to improve and excellent evaluation of performance give the school excellent capacity to improve.

## **Effectiveness of the Foundation Stage**

### **Grade: 1**

Learning is exceptionally good in the Foundation Stage. Planning is thorough, and provides the children with an excellent range of opportunities to support the development of each individual. Relationships are excellent. The excellent care, support and guidance, and high quality teaching ensure that the children reach high standards and acquire a very wide breadth of skills, knowledge and understanding. By the time they are ready to start Year 1, most children reach levels that exceed those expected nationally. The balance of class-based and intensive group activities is very good. There are frequent opportunities for children to plan what they want to do and develop good quality skills in learning independently. As a result, children enjoy developing a highly confident approach to learning.

### **What the school should do to improve further**

- Provide increased challenge in the science curriculum at all levels, in order to further raise standards
